WE CALLED FOR THE CLOSURE WHEN THE PANDEMIC STARTED AND IT WAS CLOSED ON MARCH 20, 2020. WE HELPED GET ELECTRONIC COUNTERS ON THE DRIVE AND THEY DOCUMENTED 5000 PEOPLE USING THE ROADWAY DAILY AND NEARLY 10,000 ON WEEKENDS. WE CREATED AN ONLINE GUIDE TO THE DRIVE HIGHLIGHTING INDEGO STATIONS, PARKING AREAS AND GREEN SPACES. OVER 5000 SIGNED OUR PETITION ASKING THAT THE SPACE BE REIMAGINED AS A SHARED ROADWAY.
