- Work on BCGP Annual Bike Counts and the Circuit Trails, the 800-mile regional trail network, duties include:
 - Oversee the coordination and data collection of the Bicycle Coalition's annual bike counts
 - o Manage and schedule bike count volunteers
 - o Perform bike counts in the field
 - o Preform data entry in the office
 - o Calculate and analyze the bike count data
 - o Work with the Research Director to complete the annual bike count report
 - o Assist the Policy Department with Circuit Trails outreach and research
 - o Assist the Policy Director with various tasks as needed
 - o Make field visit to Circuit Trails for photos and construction updates
